### **1. Minutes of the May 12, 2003 Business Meeting**

#### **4. Treasurer's Report:**

Craven presented a summary of the financial state of the CGU as of December 31, 2003. \$120,000 in balance.

**MOTION:** Garth van der Kamp moved that the Treasurer's report be accepted; seconded by Don Russell. Carried unanimously.

#### **5. NSERC Program Summary (David Bowen - NSERC Program Chair)**

NSERC's new initiatives were presented, including regional offices, college and community innovation program, research capacity development in small universities, Centres for Research in Youth, Science Teaching and Learning (CRYSTALs), the Brockhouse Canada Prize. NSERC budget 2004-2005 has been increased by \$39M, most of which will go to Research Tools and Instruments Grant I (\$27M) and Discovery Grant (\$3M). The Research Tools and Instruments Grant II and III (> \$150,000) will likely be canceled. Program updates were also presented. Northern Research Supplements received 120 proposals, of which 55 were funded at about \$10,000 each.
