Brown – Financially CGU is strong. Currently CGU has approximately \$164,000 in assets. The CGU 2018 meeting in Niagara Falls made approximately \$33,000. The IUGG meeting is financially good. We are looking at a \$60,000 surplus this year.

6. Equity, Diversity and Inclusivity Committee Update

Oswald – The committee, comprised of Oswald, Cockburn, Moore and two students, was struck last year in response to EDI discussions. The committee has drafted 4 goals which will be circulated to the CGU members for review and then posted to the website.

7. Future CGU Conferences

Mitchell – The 2020 CGU Conference will be in Banff, Alberta from May 3-6, 2020 at the Banff Park Lodge. CGU is focused on keeping costs low for students. Scott Ketcheson and Felix Nwaishi are leading Local Organizing Committee.

Mitchell – The 2021 CGU Conference will potentially be a combined meeting with AGU in Ottawa.
